We believe simple, practical products can provide kids living in poverty with life-changing opportunities to succeed. Production: We believe that providing individuals living in poverty with a job producing these life-changing products will provide families living in poverty with life-changing opportunities to succeed. Profession: Innovative products and in turn production are fueled by the ideas of innovative individuals. We believe by providing opportunities for entrepreneurs to launch their ideas and start or grow their business will provide entrepreneurs living in poverty with life-changing opportunities to succeed.**

**The Shoe That Grows - Our first product is "The Shoe That Grows" - a shoe that expands with the growing feet of children. The shoe is designed for children living in extreme poverty and is designed to grow 5+ sizes and last for years. We distribute our shoes to kids in need by sending them along with churches, nonprofits, and other missions related organizations that travel overseas to serve children in need. We're focused on making the current design as great as it can be, adding new designs, and using production of the shoes to provide jobs to those that need it most. In 2016, we distributed 40,309 pairs of The Shoe That Grows in 78 countries and 489 groups, with a grand total of 68,389 pairs distributed to children all over the world.**

**Bednet Buddy - designed as a free-standing and fun mosquito net. While a traditional bed net has limitations where it can be hung, Bednet Buddy unfolds like a small tent and can be used inside or outside, so that a child can always have protection from mosquitos regardless where they sleep. Also, it attempts to solve another problem with a traditional net - compliance. Although many children do have access to traditional bed nets, they do not always use them for a variety of reasons. To help promote compliance, we have specially designed Bednet Buddy to be fun by using attractive colors and prints. Malaria is a major problem in so many parts of the world, and Bednet Buddy fits a niche market where a traditional bed net lacks functionality and compliance. Bednet Buddy went from idea to prototype in 2016, with field testing being conducted on 20 units in 5 countries.**
